**NOTICE INVITING QUOTATION****SOIL INVESTIGATION WORKS FOR DISTRICT HOSPITAL KOTTAYAM**

Sealed quotations are invited by M/s INKEL Limited having its registered office at Door No. 7/473ZA – 5 & 6, 2nd Floor, Ajiyal Complex, Kakkanad, Cochin 682030, so as to reach the undersigned on or before **12/01/2018** up to 2.30pm for carrying out the work listed below. The quotations received will be opened at 3.00pm on the same day. The description of works to be carried out is attached along with this document. The rates quoted shall be final and all-inclusive and nothing extra will be paid on any account. The quotations for submission shall not be sent by post or courier.

**Specific Conditions:**

1. The intending bidders should have completed at least one work of similar nature during the last three years.
2. Quotation formats can be downloaded from our website [www.inkel.in](http://www.inkel.in)
3. The intending bidders should submit the copy of ESI & EPF registration details along with the quotation.
4. The contractor's rate must be firm and include the cost of transportation of materials to the site, all applicable taxes etc. **The rates quoted by the contractor shall be firm throughout the contract period and there shall be no upward revision of the rates quoted by the contractor for any reasons whatsoever.**
5. Minimum Six (Six) numbers of bore holes shall be taken, the approximate position of which shall be mutually agreed at site with the concerned Project Manager / Engineer in charge.
6. The bore holes shall be taken to a minimum depth of 20m or to a depth where the SPT value is more than 100 (refusal). The soil strata having SPT value greater than 100 should further be explored 2m to ensure consistency of the strata.
7. If SPT value of more than 100 is **not** achieved, then the undisturbed samples of soil collected from each bore hole shall be sent for the following tests:
  - (a) Triaxial test
  - (b) Sieve analysis
8. The report shall contain information regarding the general site conditions, depth of ground water table, soil profile (bore log) with SPT value and discussion regarding the suitable type of foundation for the above said building.

9. The quantity mentioned in the BOQ is indicative only. The payment shall be based on the actual depths of bore holes as certified by INKEL.
10. The payment terms for the work shall be released within 30 days of receipt of test reports, recommendations and invoice for the project.
11. The duration of contract shall be 30 days from the award of work.
