- The proforma for submitting the quotation will be available at the Office of INKEL Limited, Kakkanad upto 18th February 2019, 5.00PM. Or the same can be downloaded from the website 'www.inkel.in' at free of cost.
- The Participants shall have to submit an Earnest Money Deposit (EMD) of Rs. 10,000/- in the form of a Demand Draft taken from any Scheduled bank in favour of INKEL Limited, Kochi.
- The quotation shall be submitted along with EMD in sealed cover upto 20th February 2019, 12.00 Noon at the office of INKEL Limited, Kochi.
- The cover superscribed with 'Quotation for Dismantling and Removing Old Treasury Building at Malayinkeezhu' shall be submitted to the Managing Director, INKEL Limited, Post Office Road, Kakkanad, Kochi-682030.
- Quotations can also be submitted to the Sub Treasury Officer, Malayinkeezhu on 22nd February 2019 before 11.00AM.
- The Quotation forms submitted without EMD will be rejected. The quotations submitted without signature of the bidder will also be rejected without any further notice.
- Quotations will be opened on 22nd February 3.00PM within the premise of Sub Treasury- Malayinkeezhu.
- INKEL shall have the authority to postpone the tender or alter the terms and conditions without any prior notice.
- The participants can visit the Treasury building during office timings with prior permission from the Sub- treasury officer from 13th February 2019 onwards.
- The participant who quoted the highest amount shall have to deposit the quoted amount in the prescribed Treasury Account within 3 days of obtaining notice, or else the EMD shall be forfeited.

- The amounts related to this work shall be deposited in the Treasury Account with number- **'0070-60-800-42'** and the original receipt of chellan for the deposited amount shall be submitted to the Sub Treasury Officer, Malayinkeezhu.
- The building shall be dismantled upto plinth level and the debris shall be removed from the premises within 7 days.
- The EMD of the selected bidder shall be treated as the security deposit for the work and shall be refunded once the work is completed and all the debris/ scrap have been removed satisfactorily from the premises.
- The EMD of the unsuccessful bidders shall be refunded after execution of agreement with the successful bidder.
