## ANNEXURE-1:

### Indicative Scope of Work:

1. This scope involves, design, supply, installation, testing and commissioning of high security Solar Fencing for the purpose of deterrence, detection and movement control of people / Animals and unwarranted trespassing into the premises.
2. This system shall include all equipment, hardware, cabling, and ancillary service as required to complete the functionality of solar fence in all respects. This shall include providing of necessary supporting posts, main post and intermediate post.
3. Collection of all relevant data from the site which is necessary for the proper designing, layout, Installation and successful commissioning of the system.
4. Preparation and submission of realistic engineering designing of all the devices or components and sub-systems that is required for systems.
5. The design details should indicate the number of wires/lines, distance between wires/lines, number of sections, number of posts, number of intermediate posts and other accessories required for solar fencing.
6. The below Drawings should be submitted before the commencement of work.
  - 6.1. Section between two intermediate Posts.
  - 6.2. Section Post
  - 6.3. Corner Post
  - 6.4. Gate including both posts showing all the lines and wires and accessories to be fixed.
  - 6.5. Grouting details of post.
7. All civil works related with the installation, commissioning of the system.
8. Supply, Transportation and arrangement of safe keeping of the components at the site.
