Specific Conditions

1. Eligibility Criteria

The intending bidders shall be a registered civil contractor of Class 'C' and above in Kerala Public Works Department. Bids of ineligible applicants shall be summarily rejected.

2. <u>Issue Of Quotation</u>

The intending bidder, who has the requisite experience in this field can download the quotation form from our website *www.inkel.in*

3. Item Rate Contract

This work shall be item rate contract inclusive of all taxes. The contractor's rate must be firm and include the cost of transportation of materials to the site.

7. Performance Guarantee and Performance Security Deposit

7.1 The successful bidder within 7 days of receipt of the acceptance letter is required to submit an irrevocable Performance Guarantee of 5% of the total quoted amount in the form of DD/BG in

7.2 The performance guarantee will be refunded after recording of the completion certificate of the work by the Engineer-in-charge.

8. Period Of Construction

The period of contract shall be **45 days**. Commencement of the work shall be considered from the 7th day of receipt of acceptance letter.

9. All Inclusive Rates

The contractor's rate must be firm and include the cost of transportation, loading/unloading of materials to the site, statutory levies & applicable cess etc. and the fixing or placing in position for which the item of work is intended to be operated. The rates quoted by the contractor shall be firm throughout the contract period and there shall be no upward revision of the rates quoted by the contractor for any reasons whatsoever.

The quantities indicated in Schedule of Quantities are tentative and may vary according to the site conditions.

10. Compensation For Delay

- 10.1 A penalty of INR 1000/ day shall be withheld from the contractor for delay in completion of work. The withheld amount shall be released if the completion of whole of works is finished as per the above period of completion.
- 10.2 However, the total compensation for delay deductable against Liquidated Damages (LD) whether for non-achievement of milestone or for final completion shall not exceed 10% of the contract value.
- 10.3 INKEL Limited reserves the right to rescind the contract if the contractor fails to start the work within 1/8th of stipulated time or fails to complete the work within the stipulated time, after serving 7 days notice to this effect by INKEL Limited and the balance works will be executed at the risk and cost of the contractor.

11. <u>Defects Liability Period</u>

Any defect developed within the Defect Liability Period of **six months** will have to be rectified by the contractor at their own cost and in case the defects are not rectified by the contractor, INKEL or its authorized representative shall get the work done at the risk and cost of the contractor.

12. Co-Ordination Of Work

The contractor must co-ordinate with other contractors involved in other related works within the site to minimize the disruption of continuous works.

13. <u>Insurance</u>

Contractor has to obtain Workmen's Compensation policy for the workmen deployed and INKEL shall not be responsible for any loss suffered during the execution of work.


